### **1. Information We Collect**

When you opt-in to receive SMS or MMS messages from Aspire Aviation, we may collect the following information:

- Your mobile phone number
- Your name (if provided)
- Any responses or interactions you have with our messages
- Any additional information you provide voluntarily

### **2. How We Use Your Information**

We use the information collected for the following purposes:

- To comply with legal and regulatory requirements

### **3. How We Share Your Information**
